Crimes of Note

Burglary (Commercial and Residential)

Burglary – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

1/2	5:35am	Burglary, Residence 600 BLK of Broadway	An unknown suspect entered the victim's apartment that was left opened and stole property.
1/3	11:50pm	Burglary, Commercial 200 BLK of Sutter	Two unknown suspects shattered the front glass door and stole property.

The padlocks that secured the roll up door were cut and the suspects had burglary tools on them. The officers took the suspects into custody. Arrest made.
1/6	1:00am	Burglary, Residence 900 BLK of Bay	Two unknown suspects stole the apartment building key from the lockbox and entered the building. The suspects stole property from the storage units.
1/6	4:46am	Burglary, Commercial 200 BLK of Grant	An unknown suspect climbed the fire escape ladder and opened the office window. The suspect entered the office and exited through the front door. No items were stolen.
1/6	4:00pm	Burglary, Commercial 200 BLK of Kearny	Two unknown suspects damaged the metal gate lock and entered through the unlocked door. The suspects stole property and fled the scene.

Robbery – Robbery is the taking of property from another by using force or by using fear.

1/1	5:12pm	Robbery, Commercial, With Force 100 BLK of O'Farrell	Two unknown suspects entered the store and stole merchandise. The victim tried to stop the suspects at the door, but was pushed by one of the suspects. The suspects then fled the scene.

1/1	8:35pm	Robbery, With Force 500 BLK of Embarcadero	The suspect gestured to the victim to come close to him. The victim walked to the suspect and he pinned the victim against a wall. The suspect demanded money. Fearing for his safety, the victim gave the suspect money. The suspect then fled in a vehicle. Officers located the suspect vehicle as he was driving away and took him into custody. Arrest made.
1/1	8:46pm	Robbery, Commercial, With Force 100 BLK of Powell	An unknown suspect entered the store and stole merchandise. The victim confronted the suspect and he pushed the victim twice. The suspect then fled the scene.
1/4	12:25pm	Robbery, Commercial, With Force 2500 BLK of Jones	An unknown suspect entered the store and stole merchandise. The victim tried to stop the suspect at the door. The suspect moved his arm in a fashion like he had a gun. Fearing that the suspect may have a gun, the victim stepped aside and the suspect fled the scene.
1/5	6:48pm	Robbery, Attempt, With Force 700 BLK of Grant	An unknown suspect approached the two victims and demanded money. The victims continued walking and the suspect now accompanied by five other suspects surrounded the victims. The victims refused to give them money and the victims were punched in the head. The suspects tried to grab one of the victims' cell phone, but was unsuccessful. The suspects then fled the scene.
1/6	12:15pm	Robbery, Commercial, With Force 300 BLK of Sutter	Two unknown suspects entered the store and stole merchandise. The victim tried to stop the suspects at the door, but one of the suspects pushed the victim into the door. The suspects then fled the scene.
1/6	8:45pm	Robbery, Attempt, Commercial, With Force 100 BLK of Powell	An unknown suspect entered the store and concealed an item in his bag. The victim grabbed the item in the suspect's bag and the suspect pushed the victim into a pillar. The suspect then fled the scene.
1/8	6:20pm	Robbery, With Gun Francisco/Powell	An unknown suspect approached the victim from behind while holding a gun. The suspect demanded the victim's property. Fearing for her safety, the victim gave the suspect her bag. The suspect then fled the scene.
1/9	3:43pm	Robbery, Commercial, With Force 1100 BLK of Columbus	An unknown suspect entered the store and stole merchandise. The victim confronted the suspect and the suspect swung at her, but did not make contact. The suspect pushed a second victim as he walked out of the store and fled the scene.
1/12	8:40pm	Robbery, Commercial, With Force 100 BLK of O'Farrell	The suspect entered the store and stole merchandise. The suspect was stopped by security outside of the store. The suspect resisted and had a knife hanging from his neck. During the struggle, the victim suffered a cut from the knife. An officer responded and took the suspect into custody. Arrest made.





Vehicle Burglary, Conspiracy, Possession of Stolen Property- Arrest Made

12/31/18 6:40pm
100 BLK of North Point St

On 12/31/18, Central undercover officers witnessed two suspects burglarize a parked car on the 100 block of North Point St. When officers attempted to take both suspects into custody, the suspects fled on foot. One suspect escaped, and the second suspect was taken into custody. Officers found a window punch (burglary tool) in the suspect's possession. The suspect was booked at the county jail for burglary, conspiracy, possession of stolen property, possession of burglary tools, and resisting arrest.

Robbery with Force, Traffic Violation Arrest - Arrest Made

01/01/19 8:35pm
500 BLK of Embarcadero

On 1/1/19, Central Officers responded to Pier 27 on a report of a robbery where a suspect grabbed a victim by the collar and said, "Give me all your money!" The victim feared for her life and gave the suspect \$20.00. Responding officers searched for the suspect vehicle and located it traveling near the intersection of Columbus Ave and Bay St. Officers conducted a traffic stop on the vehicle and took the suspect into custody without incident. The victim positively identified the suspect and suspect vehicle at the scene. The suspect was booked at the county jail for robbery and driving with a suspended driver's license.

Possess of Methamphetamine for Sale, Possession of Heroin for Sale, Possession of Cocaine for Sale – Arrest Made

Polk St/Geary St

On 1/9/19, Central Officers observed a suspect with an open container of alcohol in an area known for high narcotics activity, Geary St and Polk St. Officers observed packaged heroin for sale in plain view from the suspect's open jacket pocket. Officers placed the subject under arrest and located additional cocaine packaged for sale, cocaine base packaged for sale, and one bag of methamphetamine on the suspect's person. The suspect was booked at the County Jail for possession of heroin, cocaine, and methamphetamine for sale.

Vehicle Burglary, Possession of Burglary Tools - Arrest Made

2500 BLK of Powell St

On 1/6/19, Central Undercover Officers conducted surveillance on the 2500 block of Powell St and recognized a suspect they arrested in the past for vehicle burglary in the area. Officers watched the suspect look into the windows of parked cars until the suspect broke out a window to one car. Officers quickly took the suspect into custody and booked him at the County Jail for burglary and possession of burglary tools.

Definition of Suspicious Activity

Suspicious activity is any observed behavior that could indicate a crime-related incident has been committed, or about to be committed. Unusual items or situations: A vehicle is parked in an odd location, a package/luggage is unattended, a window/door is open that is usually closed, or other out-of-the-ordinary situations occur.

Examples of Suspicious Activity:

- ◆ An individual peering into vehicles to locate any valuables left unattended.
- ◆ An individual trying door handles to vehicles, and/or residences to gain access to the vehicle and/ or residence.
- ◆ An individual checking front doors of residences to locate any unattended packages, or individuals following delivery trucks to see where the truck is dropping off packages.

Definition of Community Policing

Community policing, or community-oriented policing, is a strategy of policing that focuses on police building ties and working closely with members of the communities.

- Homeless Outreach and Outreach to Drug Users: Central Station officers coordinate with city agencies to provide outreach and assistance to rehabilitate those who are dependent on illegal drugs and outreach to homeless individuals to connect them with resources and support.
- Foot Patrols: Central Station have beat officers assigned to Union Square, Fisherman's Wharf, Chinatown, North Beach and Market/Drumm area.
- Monthly Police Community Relations Meetings: Community Meetings are held continuously. Officers also attend meetings with merchants groups, business groups, development authorities and others. Concerns are voiced and addressed through problem solving.
- Email Updates: Central Station sends out newsletter updates to residents in the District that alerts residents of crime trends, upcoming community events, crime prevention tips, and information on how to contact officers at the District Station.

Auxiliary Law Enforcement Response Team (ALERT)



Are you someone who is interested in disaster preparedness and wants to help out your community while working hand in hand with Law Enforcement? If so, then the ALERT program is for you!



What is the ALERT Program?

The San Francisco Police Department Auxiliary Law Enforcement Response Team (ALERT) is a volunteer citizen disaster preparedness program. The ALERT program trains members of the public to assist Law Enforcement in essential tasks after a major disaster, and in other identified non-disaster activities. Such tasks may include: traffic control, foot patrols of business and residential areas, reporting criminal activity etc. Volunteers must be at least 16 years of age and must live, work, or attend school in San Francisco.

The ALERT program is modeled after, and works in partnership with, the San Francisco Fire Department Neighborhood Emergency Response Team (NERT) program.

Three Ways To Become An ALERT volunteer:

After clearing a basic background check you will be eligible to register for one of our triannual ALERT training classes as follows:

1. Complete two 8 hour classes with ALERT, or,
2. If you are already NERT Certified, complete one 8 hour class with ALERT, or,
3. If you are an SFPD Community Police Academy graduate, complete one 8 hour class with ALERT.


