The San Francisco Police Department stands by its commitment to fostering trust and cooperation with all the people of our City. We encourage everyone to communicate with San Francisco police officers without fear of inquiry regarding their immigration status. San Francisco has been a sanctuary city under Mayor Lee, as well as under previous mayors, and we will continue to be a sanctuary city moving forward.

In 1989, San Francisco passed the "City and County of Refuge" ordinance. The officers of the San Francisco Police Department follow a specific policy regarding the enforcement of immigration laws. Officers will not stop, question or detain any individual solely because of the individual's national origin, appearance, inability to speak English or immigration status. Officers will not require individuals to produce any document to prove their immigration status. Furthermore, officers will not assist ICE in any investigation, detention, or arrest for the purpose of enforcing federal immigration laws.

The officers of Central Station are dedicated to adhering to the long standing Sanctuary City policy of San Francisco. Citizens in the Central District can always count on the Officers of the SFPD to keep building trust and partnership with the community. No one should hesitate calling upon SFPD during an emergency or to report crime because of their immigration status.

Featured Officer of the Month

Officer Christopher Sabella

Each month Central Police Station features one of its officers in an effort to learn more about the men and women who police our neighborhood. This month, we interviewed Officer Christopher Sabella, a 1-year member of Central Police Station.



Officer Sabella is a 5th generation born and raised San Franciscan. He grew up on Mt. Davidson, west of Twin Peaks. Officer Sabella graduated high school at Sacred Heart Cathedral Prep and graduated from City College of San Francisco with an Associate's Degree in Criminal Justice.

Officer Sabella joined the San Francisco Police Department in May 2014. After graduating from the Police Academy, he was assigned to Ingleside Station for his field training station. After completing field training, he was assigned to Northern Station for his probation station. After probation in May 2016, he was assigned to Central Station for his permanent assignment. Officer Sabella is the Fisherman's Wharf Beat Officer for Central Station and is Crisis Intervention Trained.

Officer Sabella thinks the culture and history of Central District is amazing. "I like working on some of the oldest streets of San Francisco. The people who live and work in this district are always ready for a good conversation and very welcoming. As a child, I used to go down to The Wharf and help in the back of my family's old restaurant, A'Sabella's. I have been able to reconnect with my family's history, all originating on The Wharf and bring back my family to a neighborhood that my family has been a part of since 1880's."

Burglary – The intent upon entry into a property to commit grand theft, petty theft, or any felony.

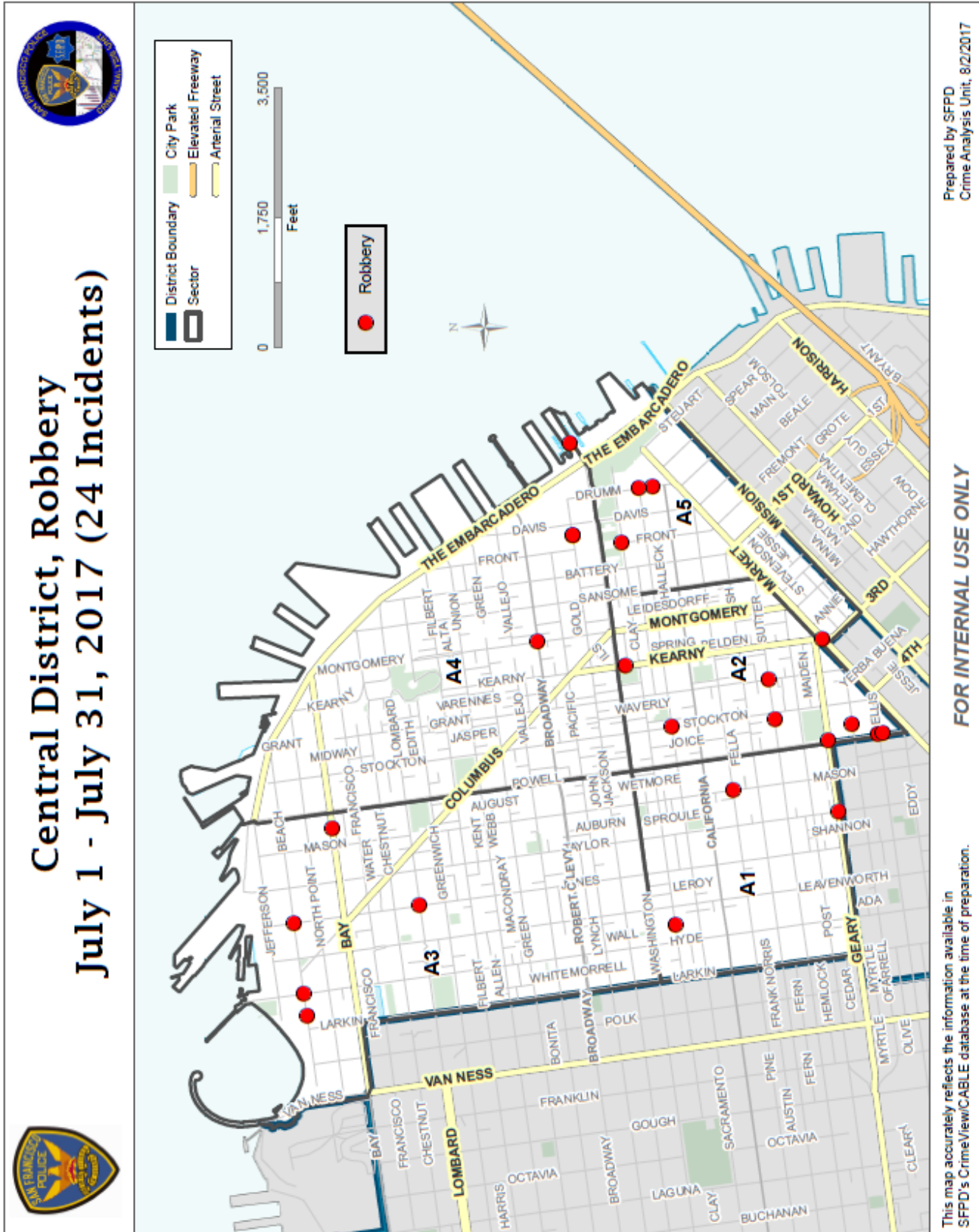

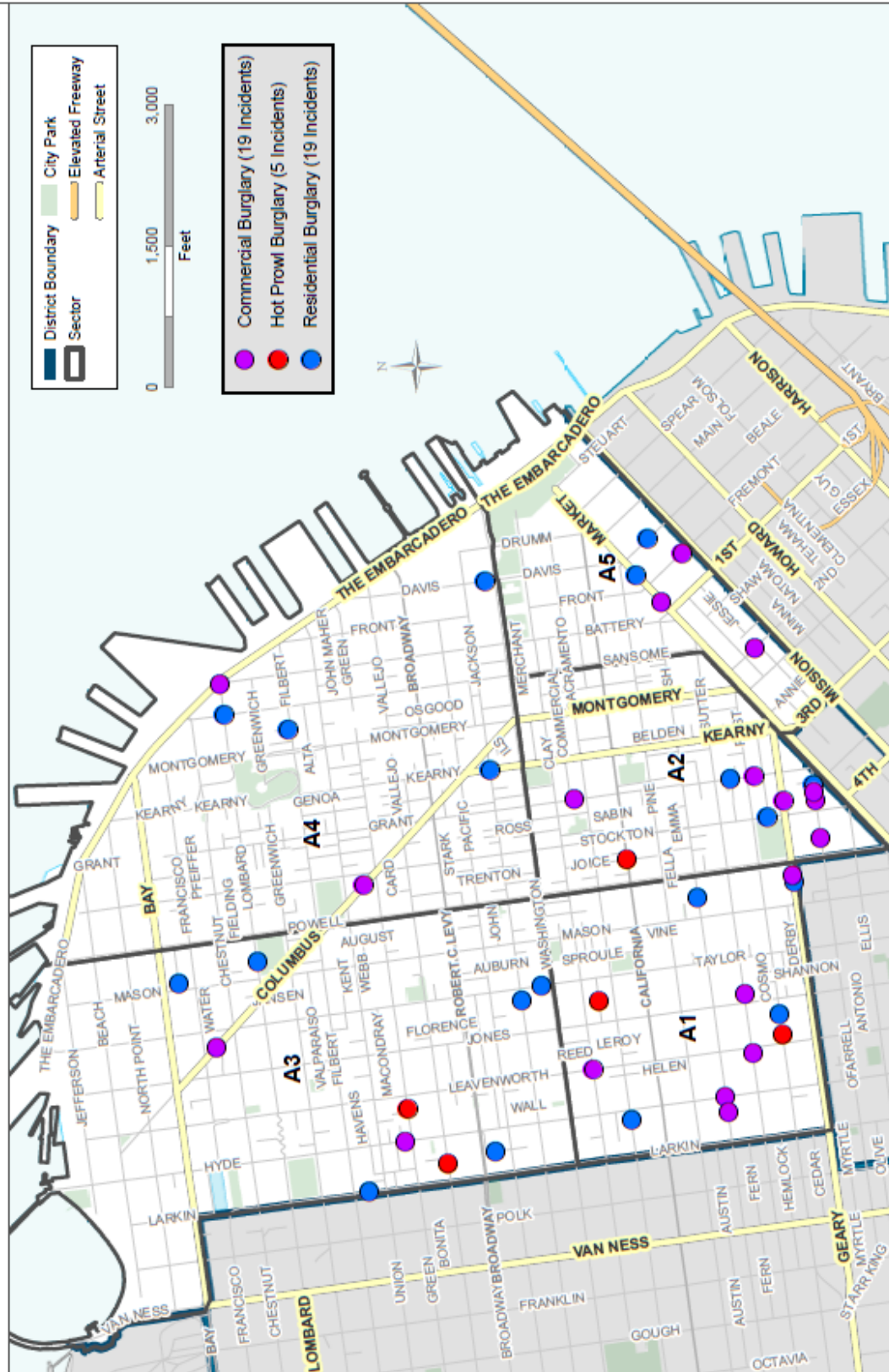

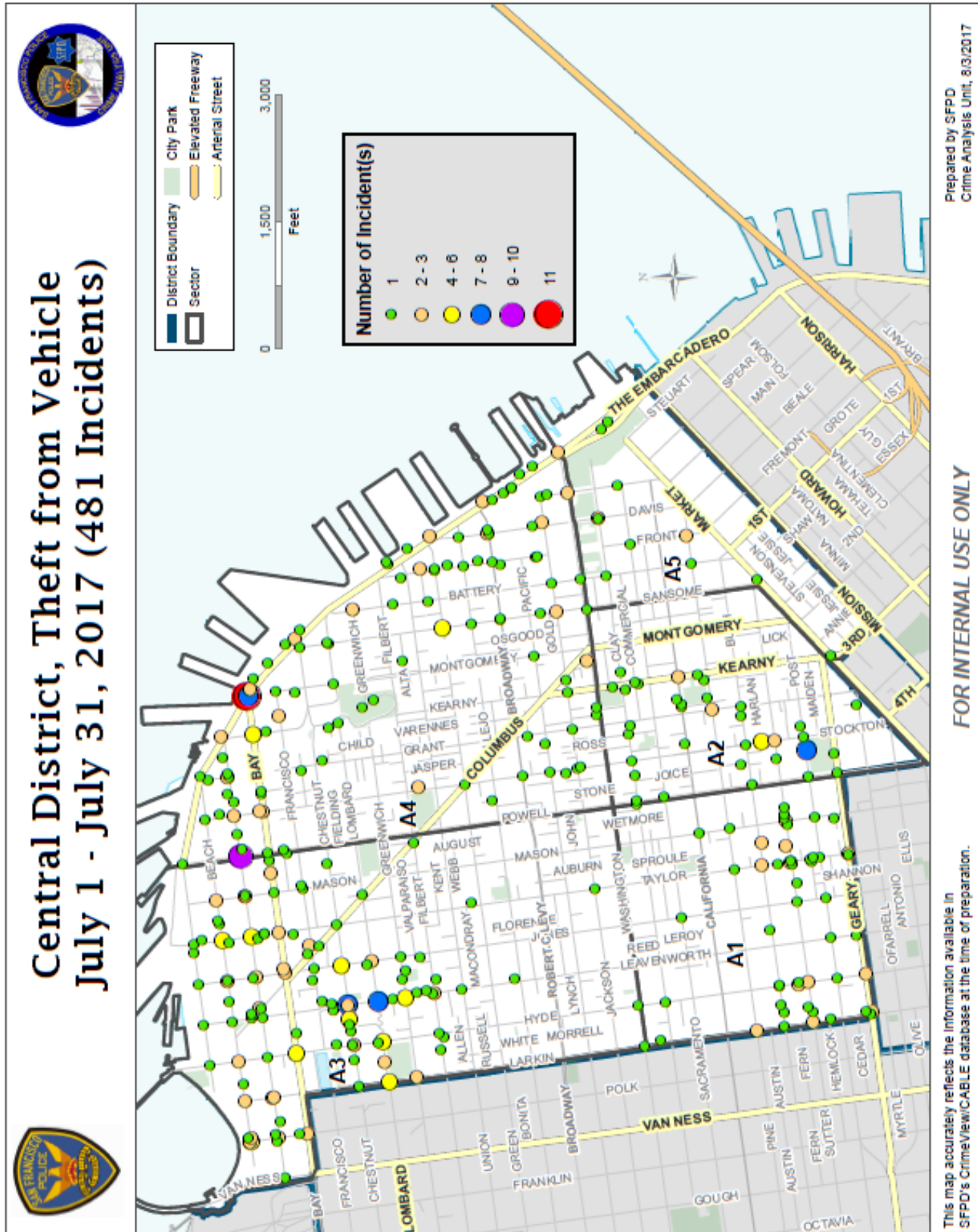
Central District, Burglary July 1 - July 31, 2017 (43 Incidents)

Incidents of Note

BATTERY, OF A POLICE OFFICER/ RESISITING DELAYING/ OBSTRUCTING PEACE OFFICER DUTIES– 615 Front Street – 08/21/17, 12:51



An officer responded to a suspect disrupting a business. The officer found the suspect needing medical attention and summoned an ambulance immediately. The suspect attempted to flee the store and ran into the middle of the street. The suspect then confronted the officer and attempted numerous punches on the officer. The suspect then used his belt and buckle to attempt to strike the officer. The officer restrained the suspect with the help of good Samaritans. The suspect was arrested and taken to the hospital. After the suspect was medically cleared he resisted officers again while preparing him for transport to County Jail.

WARRANT ARREST, LOCAL SF WARRANT/ INVESTIGATIVE DETENTION/ CRIMINAL THREATS- 145 Jackson Street– 08/22/17, 18:45



Officers responded to a person with a gun call. Officers set a perimeter and conducted a thorough search of the business and detained three suspects. A security guard believed the suspect and detained persons had a gun because of threats made during a confrontation inside the store. The suspects detained did not have a firearm. A warrant check by officers found a no bail warrant on the suspect.

THEFT, FROM LOCKED VEHICLE/ CONSPIRACY/ BURGLARY TOOLS, POSSESSION/ WARRANT ARREST/ POSSESSION OF STOLEN PROPERTY- 920 Sacramento Street– 08/23/17, 15:15

Officers responded to a call of auto burglary casing. Upon their arrival, officers saw three suspects matching the description of the auto burglary casers. Officers noticed that the suspects were in possession of large suitcases. Further investigation by the officers found that the suitcases were from a vehicle that had just been burglarized in the area. The incident was captured on surveillance and it showed the suspects in the commission of an auto burglary. The suitcases found with the suspects belonged to the victim of the auto burglary. All three suspects were booked in County jail on the above charges.





ROBBERY WITH FORCE– Vanderwater/Powell– 08/24/17, 18:49 hours

The victim told officers that she was talking on her cell phone and suddenly a suspect grabbed her cellphone from her hand. Victim chased the suspect and pushed suspect to the ground. The suspect then battered the victim and vandalized her phone and fled the scene.

BURGLARY, APARTMENT HOUSE, FORCIBLE ENTRY/ MALICIOUS MISCHIEF, VANDALISM TO PROPERTY/ BURGLARY TOOLS POSSESSION– 835 Bush Street – 08/29/17, 04:33

Officers responded to an apartment complex regarding a trespasser. Officers spoke to the building manager and located the suspect inside the building. The suspect was searched and he was in possession of burglary tools. Further investigation by Officers found video surveillance that showed the suspect making forced entry and stealing delivery boxes from residents.



BURGLARY, VEHICLE (ARREST MADE)/ CONSPIRACY/STOLEN PROPERTY POSSESSION/ POSSESSION OF BURGLARY TOOLS –Francisco St/Montgomery St– 08/29/17, 17:36



Plainclothes officers surveilled a vehicle for hours as it drove to crowded parking lots in the tourist areas of the district. The suspects would case vehicles in every location they stopped in. Officers witnessed the two suspects break into a vehicle and steal bags from the interior compartment. The suspects were taken into custody without incident. A search of the suspects located a window punch tool. A search of the suspect's vehicle found stolen electronics. Officers found the owner of the burglarized vehicle and returned the stolen items to the victims.

The San Francisco Police Department Announces Enhanced Foot Beat Deployment Strategies

The San Francisco Police Department announced today it is nearly doubling the number of uniformed foot beat officers on city streets to help prevent property and violent crimes. This strategy was developed to provide a more robust approach to identifying criminal activity and supporting the district station captains and investigators with timely and accurate, data-driven information.

"We need to change the trajectory of where crime trends are going," said Police Chief William Scott. "The data clearly shows that the presence of our uniformed personnel acts as a deterrent to crime. A more visible presence also provides the public with an increased sense of security and more opportunities to work with law enforcement to prevent crime."

The additional foot patrols are enabled by the re-purposing of personnel from investigative units and district stations. The stations will continue to focus on seven days a week beat coverage, with officers on foot and on bicycle interacting with the public. Station captains will deploy foot beat officers to known, problematic areas and have the discretion to conduct undercover operations with plainclothes patrols as well.

The department's enhanced strategy also includes a focus on education and crime prevention to address auto burglaries and crimes of opportunity, particularly in tourist areas and other neighborhoods hit hardest by these types of crimes. As part of the department's "Park Smart" program, SFPD is distributing educational, multilingual signs and posters and other materials advising residents, visitors and tourists to not leave their valuables in their vehicle.

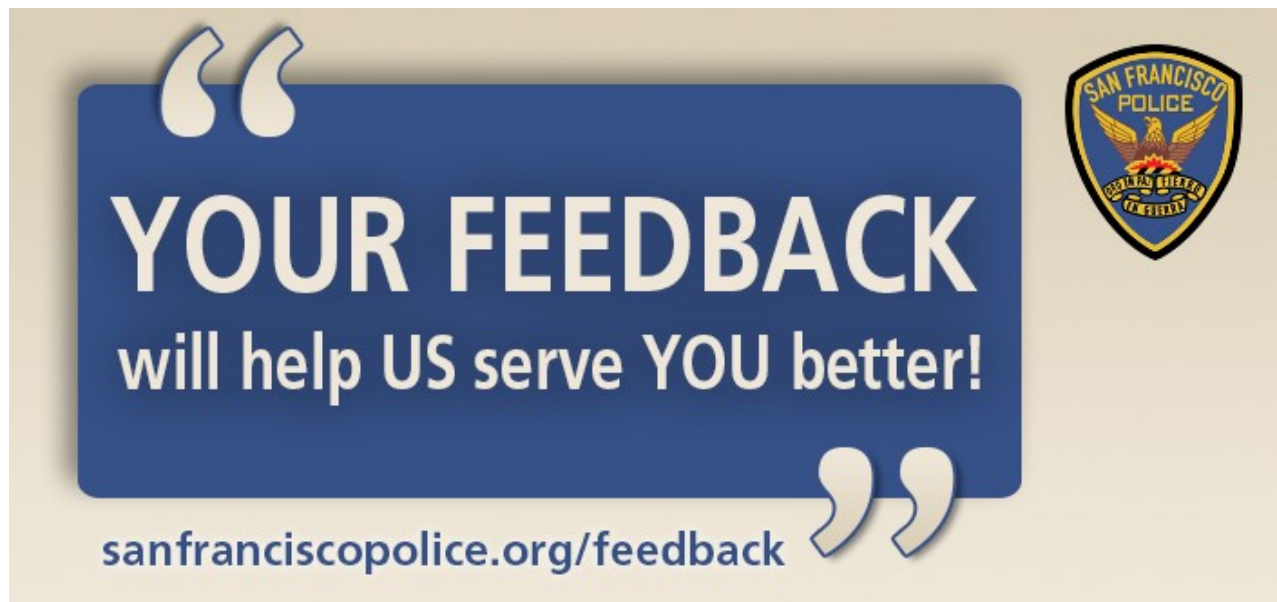
